- 1. Discuss change in plans for ADA study
 - a. Not time to do the study justice to present it in abbreviated form without some committee members reviewing.
 - b. Subcommittee:

 - iv. Likely going to look at the study in 2-hour increments during the day (starting after the holidays).
- 2. Shannon walked committee members through the process this meeting would follow.
- 3. School start times
