Data Definitions:

For 19-20 through 22-23, the official October count numbers have been used

For 23-24, numbers reflect 9/5/2023

Res: school of residence, sometimes called the "catchment"

OE: open enrollment, both choice and placement

OOD: Out of district enrollment

OE "Placement" (column Q) these numbers reflect a student who was placed in a school for needs that his/her homeschool could not provide, such as center-based programming in Special Education. These numbers are a subset of column O.

Program students are being reported to their last school of attendance. For example, a Powell 7th grader who goes over to Options Middle School will show on this report as Powell. This reflects the fluid nature of program enrollment, and is in alignment with CDE reporting practices.

For 20-21, TOPS (Online School) students are counted back to their last school of attendance, as with other program
